Call the Assessor's Office

- A quick call can confirm the exemption(s) applied to your property 847-356-2383

Review your bill

- Find your bill from last year or review the bill being mailed in May

Find your bill On-line

- Go to the Lake County Treasurer's portion of the Lake County Web Site <http://www.lakecountyiil.gov/Treasurer/payments/CurrentPaymentStatus.htm>
- Enter your PIN then select **Click Here then Scroll Down**
- Click **Display/Print Tax Bill**
